- Per beneficiary and dependent per financial year



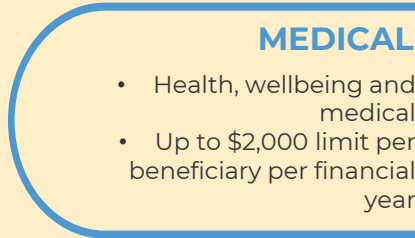
FUNERAL TRAVEL

- Up to \$1,000 limit per beneficiary per financial year



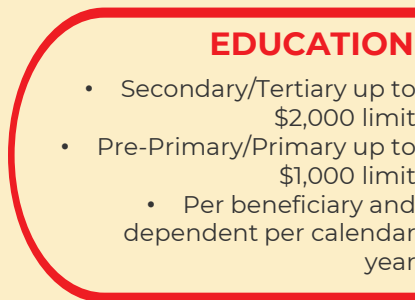
HEADSTONE

- Up to \$10,000 per headstone



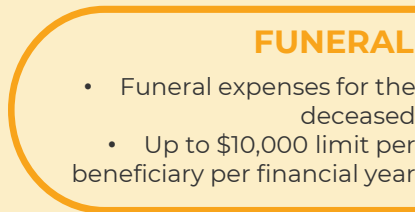
MEDICAL

- Health, wellbeing and medical
- Up to \$2,000 limit per beneficiary per financial year



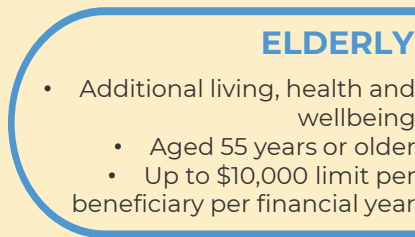
EDUCATION

- Secondary/Tertiary up to \$2,000 limit
- Pre-Primary/Primary up to \$1,000 limit
 - Per beneficiary and dependent per calendar year



FUNERAL

- Funeral expenses for the deceased
- Up to \$10,000 limit per beneficiary per financial year



ELDERLY

- Additional living, health and wellbeing
 - Aged 55 years or older
 - Up to \$10,000 limit per beneficiary per financial year

HARDSHIP

- To assist a beneficiary with the cost of **every day living up to a limit of \$5,000** per beneficiary per financial year.
- This may include food, fuel, utility bills, car repairs and maintenance, electrical goods, clothing, bedding, furniture, rental arrears, reasonable IT and phones.
- This does not include things such as payment of fines or credit card/loan debt, holidays, gaming equipment.



MEDICAL

- To assist a beneficiary with the cost of **health, wellbeing and medical expenses up to a limit of \$2,000** per beneficiary per financial year.
- This may include prescriptions, doctor or allied health professional costs, dental bills, health related equipment, health insurance fees, prescription glasses, reasonable travel to essential medical appointments.
- This does not include things such as payment of cosmetic surgery, non-prescription glasses, applications not supported by medical professional's letter.



CARER

- To assist a beneficiary with the cost of **caring for a sick or incapacitated relative up to a limit of \$500** per beneficiary per financial year.



SPORTS

- To assist a beneficiary with the cost of **participating in sporting activities up to a limit of \$500** per financial year per beneficiary and each of their registered dependents.
- This may include registration fees, uniforms, sporting equipment, gym membership fees, team registrations.
- This does not include camping equipment, recreational vehicles (such as jet skis).



FUNERAL TRAVEL

- To assist a beneficiary to **travel to funerals up to a limit of \$1,000** per beneficiary per financial year.
- This may include food and fuel to travel to a funeral.
- This does not cover accommodation or hire cars.



HEADSTONE

- To assist a beneficiary with the **cost of installing a headstone** for a Nyamal person who has passed away **up to a limit of \$10,000** per headstone.



EDUCATION

- To assist a beneficiary with the cost of **education up to a limit of \$2,000 for secondary/tertiary and \$1,000 for pre-primary and primary school per calendar year** per beneficiary and each of their registered dependent.
- This may include school fees, books, laptops or tablets, uniforms, school camps or excursions, sporting needs, bikes, musical instruments and tuition, tutor fees, canteen lunches and general school supplies.
- This does not include computer gaming equipment, mobile phones (unless basic and supported by school), flights for holidays.



FUNERAL

- To assist the family of a **deceased beneficiary** with the cost of a **funeral up to a limit of \$10,000** per beneficiary per financial year.
- This may include funeral director fees, coffin, cemetery and associated fees, flowers, clothing for immediate family, eulogy books, catering and assistance with wake.
- This does not include travel to and from a funeral, flights or accommodation (see Funeral Travel Assistance Policy).



ELDERLY

- To assist a **beneficiary 55 years or older with the additional cost of living, health and wellbeing up to a limit of \$10,000** per beneficiary per financial year.
- This may include food, fuel, motor vehicle repairs, house maintenance, rent arrears, furniture, whitegoods, clothing, utility bills.
- This does not include holidays, motor vehicles (unless exceptional circumstances), payment of loans or debts.
